- Human risks
- The different types of fire extinguishers and fire hose reels (FHR)

Practical:

- Raise the alarm, alert the emergency services
- Select and use the appropriate fire extinguishers
- Extinguishing a real fire with CO2 and water + additive extinguishers
- Using a fire hydrant
- Using a fire blanket on a pan fire

SELF-CONTAINED BREATHING APPARATUS (S.C.B.A)

Training objective

Practical:

- Knowledge test (multiple-choice questions)
- Assessment of knowledge through observation of behavior during practical work

Prerequisite: Possession of a valid medical certificate from Occupational Health stating fitness to wear the ARI.

Personnel concerned: Individuals required to work in unbreathable atmospheres using SCBA

Refresher training: Every two years

FIRE PERMIT

Training objective

Recognize and control the risks associated with hot work in order to prevent fires from starting.

- Human behavior
- Personal protective equipment
- Filling out a fire permit

Practical:

- Scenario simulation
- Drafting of the fire permit prevention plan
- Debriefing

Prerequisites: None

Personnel concerned: Anyone required to work in hot spots

Refresher training: In accordance with mandatory legal provisions and employer requirements

MOBILE FIRE UNIT (M.F.U)

Training objective

Refresher training: To be planned in accordance with mandatory legal provisions and the employer's internal requirements.



Accessible to people with reduced mobility (PRM)

Provide access for a truck measuring 12 m long by 4 m wide, with a maximum gradient of 5% and a minimum clearance height of 3.5 m.

FIRST AID (F.A)

Training objective

Be trained to provide first aid to a victim following an accident at work until emergency services arrive.

Training schedule

Theory:

- Protecting the victim, responders, and third parties
- Alerting emergency services
- First aid for the victim depending on their injuries

Practical:

- Simulation of various accidents relevant to the participants' work environment: bleeding, choking, fainting, burns, cardiopulmonary resuscitation, defibrillation, etc.
- Implementation of various technical procedures
- Practical exam

Prerequisites: None

Personnel concerned: General public

Refresher training: Refresher training scheduled every 5 years

Duration	Training Location	Languages	Number of participants

A personalized training certificate will be issued to the employer at the end of the course.

REFRESH OF FIRST AID PROCEDURES - R.F.A.P

Training objective

Be trained to provide first aid to a victim following an accident at work until emergency services arrive.

Training schedule

Theory:

- Reminder of first aid procedures

Pratique :

- Simulation of various accidents, adapted to the participants' work environment: bleeding, choking, fainting, burns, cardiopulmonary resuscitation, defibrillation, etc.
- Implementation of various technical procedures

Prerequisites: Anyone who holds a first aid certificate that is less than 5 years old.

Personnel concerned: General public

Refresher course: Recommended for maintaining technical skills

- First aid for an unconscious victim who is breathing

- Role-playing different scenarios
- Using an automated external defibrillator

- Welcoming external emergency services

- Tour of the premises with trainees
- Simulation of an evacuation drill
